Consent Agenda:

Ken Gaines motioned to approve the November Minutes. **Joe Henson** 2nd. RCVMC

Unfinished Business:

- A. drainage project: Tabled
- B. Amy replied to the Ameren email to accept the \$750 settlement. When she receives the paperwork, Ted will need to sign and get notarized.
- C. Paid Leave for all Worker Act (PLAWA): The resolution is going to be amended because the current document states the clerk will only work 30 hours a month. Jim Thompson brought up that the clerk may work more than that on certain months. Jim thinks that anytime the clerk drives to Sadorus to drop the key off or check the mail that she should get paid one hour show up time. The board agreed that this resolution couldn't be signed until the 30 hours was amended. The board agreed that the clerk will track her hours, and she will not work full time hours. The resolution also stated it was for the Village of Sadorus Clerk. Ted requested the document be changed to Village of Sadorus employee, so the same document could be used for any village employee in the future.

Attorney Report:
