**Public Forum:** Roger Rexroad stated that there is a drain is 8 inches above standing water. 217 Inc. will be notified. Kim Spencer requested that the stump left by a tree recently removed by the village be removed. The board informed her Phillip Kleiss is already scheduled to remove it. She also noticed a village entrance sign damaged by the strong winds. The County has already been notified. Kim also reported that a utility company wire is dangling on the water company's property. - C. ESDA & automated siren: The siren automation is completed. When severe weather occurs the siren will automatically be triggered by METCAD. Our local ESDA people can also activate the siren which they will do for monthly test. The ESDA responsibilities will return to the village president. Ted was notified by the FIRE DEPT that they voted to cease rendering ESDA duties and cede them back to village. The SFPD will give a county ESDA owned 800MHZ radio & base station to the village.
- D. PLAWA: Ted provided clarification about the PLAWA. On April 30 the State of Illinois finalized and published the regulations. The village will move forward with a PLAWA policy developed with the village attorney and the village president in accordance with state regulations.
